Registration Papers: A copy of futurity dog registration papers must accompany your entry.

SPECIAL RULES

1. All dogs must have current health papers ready to present upon arrival at Gate 7.
2. Trial will start promptly at 9:00 am on October 4 and 5 in the Mustang Arena.
3. This is a TIME & POINT trial.
4. Futurity dogs can run in any event prior to our futurity - MUST meet age requirements.
5. Dogs competing in Jack King Futurity may also compete in Tulsa Jackpot Series.
6. No running on course.
7. No crooks, sticks or prods. Handlers cannot have anything in their hand during the run unless handicapped and approved by Trial Director.
8. No electronic training devices are permitted on grounds. ANY unsportsman like conduct may result in a disqualification.
9. All decisions by the trial director are final.
10. Exhibitors are responsible for picking up after their own dogs. No dogs are permitted to be left unattended.

(If you have competed in Intermediate class as a novice handler you can enter this class only if you have never competed above a Novice handler status. Handler status does not affect futurity dog class. Novice class will not be eligible to enter Open or Non-Open classes and can only enter Futurity if dog meets age requirements.)	\$100.00
